Notice Inviting Nominations from Local Branches

Nominations are invited from the local branches under the State of Assam, under seals of the President and Secretary of the branches, to nominate in the prescribed nomination paper (available in the IMA ASB website and will be made available in the official social media groups, downloadable and printable) eligible members for the offices of President, two Vice Presidents, Hony. State Secretary and Hony. State Finance Secretary.

One branch can send nomination for any of the posts, and also can nominate two members for the two posts of Vice Presidents, but in two separate nomination papers. A member nominated by a local branch may not necessarily be a member of that particular branch.

All nominations should reach the undersigned within 31st October 2022.

Eligibility Criteria for the above posts (Ref. to Rule 33.a of the By-laws) :

For President minimum 10 years of Life Membership and for Vice Presidents, Hon. State Secretary & Hon. State Finance Secretary minimum 5 years of Life Membership are mandatory. Moreover the candidates for all these posts should have minimum two terms of experience as State Working Committee Member.

A member can continue in these four posts for not more than two consecutive terms of two years each and will cease to seek nomination/ contest for a third term continuously for the same post.
