Welcome Address: Welcome Address was delivered by Dr S Borah, State President.

Obituaries: The house condoles the death of Dr. Pratyush Ranjan Kaushik.

Minutes of 152nd SWC: Minutes of 152nd SWC held on 08/09/2019 at Hotel Cygnet Park, Megna, Bongaigaon were read out by HSS Dr Hemanga Baishya. There was a correction of name of Dr Angarag Bhagawati which was quoted as Dr Angarag Mahanta.

There was a discussion on role played by PDC in recent cases. Dr P.K. Agarwal informed about the status of PDC meeting. State President Dr S. Borah regretted the absence of PDC leaders in the SWC despite discussion on the murder of a plantation doctor Dr Deben Dutta. He requested plantation doctors to meet together and form a unified platform and choose their leader. The details of legal proceedings of Dr Deben Dutta case was informed by Dr S. Borah with discussion. He informed that though the case is not under Fast Track but still it is being proceeded at a significantly good speed. A letter was also sent to the Hon CM of Assam and the reply was read out in the meeting. Dr Sahadullah, Hon. Secy Jorhat, also gave details of the recent progress in the case. There was a question on the edition of the recent edition of IMA Calling which was quoted as XVI. Editor was requested to verify the edition number. It was also informed by Dr Jagadish Basumatary that the Pdf version of IMA Calling will be soon uploaded. The minutes of 152 SWC were confirmed by the house.

Report of Honorary State Secretary: HSS Dr H Baishya presented the secretarial report after welcoming all members. He mentioned about various meetings attended by IMA ASB office bearers.

Dr L. Bhuyan enquired if the information about the IMA AMS East Zone session at the Star North East Endogyn conclave, was circulated amongst the members. On denial by HSS, he was requested to circulate such information for better attendance. Dr G.S. Gogoi enquired about Dr Ghanashyam Thakuria case. Dr S. Borah informed in detail and said that Advocate K N Choudhury has taken up the case. The fee being very high (Rs 1,05,000/-) was paid by the IMA HQ on the request of the IMA ASB. Dr H. Borah enquired about the role played by PDC in the case.

HSS informed about NATCON 2019 and requested members to join in a good number. It was informed that the IMA HBI meeting on 8th December will be held at Hotel Landmark and Dr S. Borah told the detail and requested everyone to attend the meeting. He also informed about the "Awaken India" program on Dec 9th at O&G Dept at GMC.

Report of HSFS: Due to sudden sickness of HSFS Dr Rajumani Sarma, the report prepared by him was read out by Jt Secy Dr P.K. Agarwal. The pending cheques of END TB was also distributed among the branch

Secretaries present.

IMA AMS Dr L.Bhuyan presented the report. He informed regarding pending forms of 2 members of Dispur branch which were not dispatched due to some confusion and were collected during 50% discount .Dr S. Borah said that IMAASB should pay the difference of Rs 500 of both members and send the forms soon. Dr. L.Bhuyan was requested to conduct a meeting of IMAAMS during the annual meet at Tezpur in March next year.

IMA CGP Dr J. Basumatory presented the report. He requested for 2 sub faculty at Hojai and Tinsukia. Dr H.K. Borah informed that a letter has been sent to the HQ with several reminders but with no reply till date. The 2nd edition of IMA CGP was released with articles on Non Communicable Diseases. Dr H.K. Borah was congratulated for the 2nd edition in such a short duration. Dr Pranab Kr Sarmah was also thanked for his contribution of Rs 10,000/- for the editorial .Dr H.K. Borah proposed to hold the IMA CGP National conference in Assam next year. The elected Dean IMA CGP Dr. H. Adhikary agreed, and the house approved the same.

Editor IMA Calling: Editor informed that the next edition will be released in Tezpur.
